## Dog Foster Agreement

1. I hereby acknowledge receiving the above-described dog(s).
2. I understand that the dog(s) shall remain the sole property of WoofStock 2nd Chance Camp (“WSCC”). WSCC reserves the right to reclaim the dog(s) at anytime.
3. I agree to return said dog(s) if I am no longer able to care adequately for them.
4. I agree to provide the dog(s) with good and loving care, including but not limited to food, water, shelter and medication when required. I agree not to breed the dog(s) or allow them to breed. I will provide or arrange for all emergency medical care and will notify WoofStock 2nd Chance Camp immediately if the dog(s) become ill or injured, requiring veterinary care. I also agree not to allow the dog(s) to be euthanized, unless it is clearly critically injured, without notifying WoofStock 2nd Chance Camp and obtaining permission in advance.
5. I understand and acknowledge that I do not have any right or authority to keep or place foster dogs in other homes or with other individuals.
6. I understand that said dog(s) will be available for adoption during the time in my foster care, unless otherwise stated. I agree to allow the dog(s) to be viewed by potential adopters with 24 hour notice.
7. I understand that as the foster parent, I have the first right of adoption of any dog(s) in my care when adoptive homes are available.
8. I understand and acknowledge that I am responsible for all general expenses incurred as a result of fostering a dog(s).
9. I understand and acknowledge that neither WoofStock 2nd Chance Camp nor Country Meadows Pet Inn cannot guarantee or be held responsible for the health, behavior or temperament of dog(s) that I may foster. I understand that neither WoofStock 2nd Chance Camp nor Country Meadows Pet Inn make any warranty or guarantee as to the demeanor, health, temperament, or pedigree of any animal. I expressly release and hold harmless WoofStock 2nd Chance Camp from any and all liability for loss, injury, or damage caused by any animal to any person or property, and that I will assume any such risk or loss by fostering any animal.

10. I understand that my foster volunteer position can be terminated at any time at the sole discretion of WoofStock 2nd Chance Camp.
11. I agree that WoofStock 2nd Chance Camp has the right to visitation with 24 hours notice or immediate inspection in case of emergency situations.

I attest that the terms and conditions of this foster contract have been read and understood. I agree to abide by them, and I am at least 18 years of age.
